INWIT: UPDATE ON SHARE BUYBACK IN THE PERIOD 7 TO 11 AUGUST 2023

Milan, 14 August 2023 - Infrastrutture Wireless Italiane S.p.A. (INWIT), following the press release of 14 June 2023, relating to the start of the first tranche of the treasury share buyback in execution of resolution No. 1 at item No. 7 of the agenda passed by the ordinary Shareholders' Meeting on 18 April 2023, announces that it has purchased on the Milan Euronext, in the period between 7 and 11 August 2023, 363,000 ordinary shares at an average price per share of EUR 11.2609, for a total value of EUR 4,087,723.40.

Below, based on the information provided by the appointed intermediary, are the details of the treasury share buyback transactions on a daily basis:
