

Ethical and Integrity Agreement


- 1. INWIT S.p.A. ("INWIT" or "Company") is inspired by the following fundamental values and principles of business ethics, in line with the 10 principles of the United Nations Global Compact to which it has adhered and with its Code of Ethics and Policy "Diversity & Inclusion":
 - ✓ promotion and respect for human rights;
 - ✓ combating the infiltration of organized crime.
 - ✓ repudiation of any form of corruption, whether public or private, in implementation of the principle of "zero tolerance";
 - ✓ protection and protection of the environment;
 - ✓ health and safety in the workplace;
 - ✓ prohibition of forced and compulsory labour of all forms of child labour;
 - ✓ promotion of freedom of association and collective bargaining;
 - ✓ promotion of gender equality in its organization and towards its third parties and condemnation of any type of discrimination;
 - ✓ respect for the principle of fair competition.
- 2. Without prejudice to the provisions of the applicable legislation as well as the obligations assumed by the Company also following the granting of public funding, INWIT must extend the adherence of the aforementioned principles to all economic operators who want to be included in the Company's supplier register, acquire and maintain the status of "qualified / accredited supplier", participate in selection procedures or award or award of contracts ("Economic Operator" or "Supplier"), in order to ensure their correct and effective application. The Economic Operator concerned, therefore, acknowledges and accepts that these principles are an integral and substantial part of any relationship with the Company.
- 3. Aware of the responsibilities assumed, the Economic Operator undertakes to:
 - conform its conduct to the principles of loyalty, transparency, accuracy and collaboration in line with the INWIT Code of Ethics;
 - prevent any form of corruption by not offering, promising or receiving, even in the form of an attempt or solicitation, directly or indirectly - sums of money or any other benefit, in order to obtain, maintain or promise undue advantages in favor of oneself or third parties;
 - not to engage in conduct in violation of the principle of fair competition or otherwise likely to alter - directly or indirectly - the process of qualification or selection of suppliers or the award or award of contracts;
 - promote INWIT's ethical principles and values within its organization and towards its third parties;
 - promote gender equality in its organization and towards its third parties and condemnation of any type of discrimination;
 - report any event that may be contrary to the law or, in any case, distorting the market or competition in the context of the qualification, selection, award or award procedure as well as during the execution of contracts.
- 4. In order to ensure the effective application of the aforementioned principles and prevent corporate crime in line with current legislation, the Economic Operator

states:



a)	to have adopted a Code of Ethics and/or an Organization, Management and Control Model <i>pursuant</i> to Legislative Decree 231/01 ("Model 231") or, in any case, compliance programs suitable for preventing the commission of offenses in the company code;

- a) promptly communicate relevant events pursuant to point 4) that may arise during the registration, qualification, selection, award, assignment process or during the execution of the contractual relationship with INWIT;
- b) actively collaborate with INWIT in case of violation of commitments by employees or subjects attributable to the Supplier.
- **7.** In relation to the above, the Economic Operator acknowledges that, without prejudice to the applicable legislation, INWIT:
- will not maintain any type of relationship with economic operators who have not signed this document or whose declarations and commitments are not true or, in any case, reticent;
- will assume, even during the selection, award, assignment or execution of the contractual relationship, any initiative deemed appropriate for the protection of ethical values and principles, in case of non-fulfillment or violation of the commitments undertaken or false or, in any case, reticent declarations.²
