INWIT: UPDATE ON SHARE BUYBACK IN THE PERIOD 8 TO 12 APRIL 2024

Milan, 15 April 2024 – Infrastrutture Wireless Italiane S.p.A. (INWIT), following the press release of 7 March 2024, relating to the start of the second tranche of the treasury share buyback in execution of resolution No. 1 at item No. 7 of the agenda passed by the ordinary Shareholders' Meeting on 18 April 2023, announces that it has purchased on the Milan Euronext, in the period between 8 and 12 April 2024, 389,747 ordinary shares at an average price per share of EUR 9.9995, for a total countervalue of EUR 3,897,286.27.

Below, based on the information provided by the appointed intermediary, are the details of the treasury share buyback transactions on a daily basis:
