### INWIT: UPDATE ON SHARE BUYBACK IN THE PERIOD 20 TO 24 MAY 2024

Milan, 27 May 2024 – Infrastrutture Wireless Italiane S.p.A. (INWIT), following the press release of 7 March 2024, relating to the start of the second tranche of the treasury share buyback in execution of resolution No. 1 at item No. 7 of the agenda passed by the ordinary Shareholders' Meeting on 18 April 2023, announces that it has purchased on the Milan Euronext and on multilateral trading facilities, in the period between 20 and 24 May 2024, 1,438,125 ordinary shares at an average price per share of EUR 10.0064, for a total countervalue of EUR 14,390,507.93.

Below, based on the information provided by the appointed intermediary, are the details of the treasury share buyback transactions on a daily basis:
