INWIT: UPDATE ON SHARE BUYBACK IN THE PERIOD 10 TO 14 JUNE 2024

Milan, 17 June 2024 - Infrastrutture Wireless Italiane S.p.A. (INWIT), following the press release of 7 March 2024, relating to the start of the second tranche of the treasury share buyback in execution of resolution No. 1 at item No. 7 of the agenda passed by the ordinary Shareholders' Meeting on 18 April 2023, announces that it has purchased on the Milan Euronext and on multilateral trading facilities, in the period between 10 and 14 June 2024, 1,846,955 ordinary shares at an average price per share of EUR 9.7792, for a total countervalue of EUR 18,061,761.75.

Below, based on the information provided by the appointed intermediary, are the details of the treasury share buyback transactions on a daily basis:
